

What Is LitX?

LitX offers a streamlined, secure workspace for exchanging documents and files between opposing parties. Rather than piecemealingmethods together, LitX is a single destination where adversarial parties can share, view, and download all case materials.

No more hunting down records or emailing opposing counsel to ask them to resend the document. With LitX, it's all in one place.

Our platform eliminates the chaos and empowers attorneys and legal staff by allowing for real-time service of discovery while centralizing all legal documents and files into a shared and verifiable record. Exchanged information never "expires" and remains securely preserved, stored, and accessible to all parties for the life of the case.

How Secure Is LitX?

LitX employs advanced security rules and complies with other regulations governing Protected Health Information ("PHI") that require data to be secure while both at rest and "in transit," meaning actively moving between a sender and a destination.

While email is a quick and easy way to communicate electronically, it is not necessarily secure.

In fact, most current channels don't provide secure communication. Unreliable and insecure methods of exchanging documents also increase the risk of inadvertent disclosure, such as sending the material to the wrong email address, fax number, or physical address.

LitX is pursuing HIPAA compliance and has designed the platform to follow that standard.



A Verifiable Record of Discovery Documents

Tracking documents and materials exchanged between your office and opposing counsel can be challenging. LitX provides a simple solution, helping you upload, download, track and manage case files.

It also allows you to verify which files you sent or received and verify permissions and access.





A Central Docket to Send, Receive, and Manage Files

Many law firms struggle to organize documents exchanged with opposing counsel and clients. With LitX, everything is in one secure, easy-to-access place in a secure cloud.

It preserves exchanged documents and files in their original state. Much like traditional service methods (mail, e-service, email, etc.), documents and files cannot be changed, removed, or edited without the permission of all parties.

Equal Document Access

In an adversarial system, mitigating unnecessary points of contention brings significant value. LitX gives all parties equal access and control to documents and files.

All parties have the convenience of keeping discovery documents and files centralized in the cloud with the same privileges.

By providing equal control with built-in accountability, opposing parties can efficiently work together in a trusted, neutral space, eliminating much of the friction inherent in the litigation process.
